

TERMS & CONDITIONS FOR THE POST OF DEPUTY RANGER TROPICAL FOREST RESEARCH INSTITUTE, JABALPUR

The Tropical Forest Research Institute, Jabalpur a constituent unit of ICFRE an Autonomous body under the Ministry of Environment, Forests and Climate Change, Government of India. Invites applications from amongst the eligible candidates working under ICFRE / All State Forest Departments for filling up of one of Deputy Ranger on deputation basis at the Tropical Forest Research Institute, Jabalpur in Level 6 of 7th CPC Pay Matrix.

(A) Eligibility:-

- (a) Analogous posts or Foresters in the Level 4 of the 7th CPC Pay matrix 10 years of service in the grade and having successfully completed forestry training course from recognized institution.
- (b) The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

(B) Tenure:-

The tenure of deputation shall ordinarily be of 3 years extendable upto 4 years or till superannuation, whichever is earlier. The tenure can, however, be curtailed or extended by the Competent Authority subject to the performance of the individual.

(C) General Instructions:-

- 1. Interested officials should submit their application in the prescribed proforma which is enclosed herewith. The application form duly filled in and completed in all respect should be forwarded to the Director, Tropical Forest Research Institute, P.O.: R.F.R.C., Mandla Road, Jabalpur 482 021 (M.P.) through proper channel so as to reach the same to this office on or before 05/10/2022. The closing date of receipt of applications from candidates residing in Andaman & Nicobar Island and Lakshdweep will be 20/10/2022.
- 2. The forwarding authority of the officials should furnish the following information alongwith the application:-
 - A Vigilance Clearance Certificate.
 - (ii) Photocopies of Annual confidential reports for the last 5 years.

The forwarding authority should also ensure that in the event of selection of the official he should in a position to relieve/spare the official within a month of the issue of offer of appointment to him.
